Eligibility Criteria	Acceptable Proof of Eligibility
Proof of Legal Name	<p>Original or certified copy of birth certificate <i>or</i> Certificate of Degree of Indian Blood (CDIB / CIB) issued by the Bureau of Indian Affairs <i>or</i> Tribal Identification Card issued by a federally-recognized Calista Region Tribe <i>or</i> Driver's license or official identification card issued by a U.S. state, jurisdiction, or territory <i>or</i> Social Security card <i>or</i> U.S. or foreign passport <i>or</i> U.S. military identification, military dependent identification, or veteran's identification <i>and</i> If the current legal name is different from the name listed on the birth certificate or other verification documents, an applicant must provide proof of legal name change such as a marriage certificate, divorce / dissolution decree, name change court order, <i>or</i> adoption decree / court order</p>
Proof of Date of Birth	<p>Original or certified copy of birth certificate showing date of birth after December 18, 1971 <i>or</i> Emancipated minor court document (for emancipated minors) <i>or</i> Marriage certificate (for emancipated minors)</p>
Proof of Lineal Descent from original Calista Shareholder	<p>Original or certified copy of birth certificate(s) identifying the applicant <i>and</i> one natural parent, grandparent, or great grandparent, etc. linked to the applicant who is / was enrolled as original Calista Shareholder or who is a known Descendant of such a Shareholder <i>and/or</i> Lineal descent affidavit identifying the applicant <i>and</i> certifying the identity of one natural parent who is / was an original Calista Shareholder or a Descendant of such a Shareholder (if one or more parent who is an original Calista Shareholder is not listed on an applicant's birth certificate) <i>or</i> Affidavit of cultural adoption identifying the applicant <i>and</i> one natural or adoptive parent who is / was an original Calista shareholder or a Descendant of such a Shareholder <i>or</i> Adoption form and decree / court order or tribal resolution identifying the applicant <i>and</i> one natural or adoptive parent who is / was an original Calista Shareholder or a Descendant of such a Shareholder</p>
