| <b>Proof of Date of Birth</b>   | <p>Original or certified copy of birth certificate showing date of birth on or before December 18, 1971<br/>or<br/>Certificate of Degree of Indian Blood (CDIB / CIB) issued by Bureau of Indian Affairs<br/>or<br/>Affidavit showing birth date<br/>or<br/>Early public records listing date of birth for applicants who were not issued a birth certificate (such as a baptismal record, census record, etc.)</p>   |
| <b>Proof of Ties to Calista Region and/or Lineal Descent from Someone from the Calista Region (for Class D applicants only)</b> | <p>Original or certified copy of birth certificate showing birth place in the Calista region or showing lineal descent from a parent, grandparent, or great-grandparent, etc., who is / was from the Calista region<br/>or<br/>Affidavit that the Native: <ul style="list-style-type: none"> <li>• resided in the Calista region on the 1970 census date (April 1, 1970)<br/>or</li> <li>• resided in the Calista region for a total of ten or more years before the 1970 Census<br/>or</li> <li>• identifies lineal descent from a parent, grandparent, great grandparent, etc. who is / was from the Calista region</li> </ul> Adoption form and decree / court order or tribal resolution that identify lineal ties to the Calista region.</p>   |
